Incomplete applications will not be processed. Membership in the National Rifle Association (NRA) is a prerequisite for membership in PSC (one per membership). NRA applications are available at the Range Office. Presently we have a cap of 750 memberships. If your application cannot be processed because of the cap, your check or money order will not be deposited and you will be placed on a waiting list. The waiting list is first come first served and you will be notified when we have an opening. If you are submitting this application to be placed on the waiting list, please check the box in the line at the bottom of this page.

Annual dues are due and payable before April 1<sup>st</sup> of each year. Renewal notice of dues will appear on the web page and we will send an e-mail reminder if you provide us with your address. ### Liability Release and Disclaimer

As a condition of membership in the Poulsbo Sportsman Club, Inc., hereinafter referred to as PSC, I hereby release, discharge and agree to hold harmless PSC, its directors, officers, agents and servants, and any sponsors, donors, and contributors of PSC from all liability, claims, demands or actions that might arise out of: 1., any damage, loss, injury, or death which I might sustain; and/or 2., and any theft, unexplained disappearance or damage that might befall any property belonging to me or in my possession while on PSC property.

I have read, fully understand and agree to all the terms of this liability and disclaimer statement. I understand that the terms herein are absolute and not mere recital.
